## ELGIN MAN PLEADS GUILTY TO MURDERING WIFE

RE: Victor H. Ayllon: Age 38 (d.o.b. 11-08-1985), of the 300 block of Heine Avenue, Elgin, Illinois. Case No. 2021CF1252.

**St. Charles, Ill. -** Kane County State's Attorney Jamie L. Mosser announces that Victor H. Ayllon has pled guilty to the offense of first-degree murder, Class M felony.

Judge DJ Tegeler accepted the plea and set Ayllon's next court appearance for June 20, 2024 at 1:30 p.m. in Courtroom 313 at the Kane County Judicial Center for sentencing.

State's Attorney Jamie Mosser stated the following facts in court:

On July 12, 2021, a 4-year-old boy was found during the evening hours walking alone at the intersection of Lawrence Ave and N. Aldine Ave in Elgin. Upon investigation, officers were able to determine his address in the 300 block of Heine Avenue in Elgin. Officers went to that location and found a 3-year-old boy in the home. They further found the body of Wendy Ayllon on the floor. The victim was unresponsive and believed to be deceased. The victim was the mother of both the 3-year-old and the 4-year-old.

Investigators then attempted to locate her husband, the defendant, Victor Ayllon. They found him at the home of his parents with faint marks on his wrists. He was taken to the hospital and subsequently released to the police. Investigators learned that the victim in this case had picked up the defendant in the early morning hours on July 12. They arrived back at the home at 2:16 a.m. The defendant later leaves the home via car at 3:16 a.m. A camera within the home captured the sound of arguing and the victim screaming followed by a thud during this time period.

The defendant was interviewed and admitted that he and the victim had been in an argument where the defendant accused her of infidelity (no evidence of which was ever revealed to corroborate this) and the defendant's drug addiction. The defendant then strangled the victim to death and left her body with the two minor children.

An autopsy confirmed that the victim died of manual strangulation.

Ayllon faces a sentence of 20-60 years of imprisonment in the Illinois Department of Corrections followed by a 4-year mandatory supervised release period.

Ayllon remains in custody at the Kane County jail.

**SA Mosser said**: "The heinous action of the defendant, who callously strangled his wife to death and left her body with their two young children, is utterly reprehensible. His selfish attempt to evade responsibility for his abhorrent actions demonstrates a complete disregard for human life and parental duty. The guilty plea secured today brings some measure of justice for Wendy Ayllon, whose life was tragically cut short, and her family. We will continue to seek the appropriate punishment for this senseless act of violence. Our thoughts remain with the victims, particularly the young children who have been left traumatized by this horrific ordeal. My thanks to Elgin Detectives Chris Hughes and Chris Valle and the Elgin Police Department for their thorough investigation that resulted in the defendant pleading guilty to this crime."
