### **CARPENTERSVILLE COUSINS FACE MURDER CHARGES IN OCTOBER 25 SHOOTING THAT LEFT 17-YEAR-OLD DEAD**

November 1, 2023

*RE: Alan U. Medina: Age 19 (d.o.b. 11-7-2003), of the 100 block of Pecos Circle, Carpentersville, Illinois. Case No. 2023CF2314 and Jimmy Medina: Age 16 (d.o.b. 11-13-2006), of the 200 block of Ensenada Drive, Carpentersville, Illinois. Case No. 2023CF2315*

Kane County State's Attorney Jamie L. Mosser and Village of Carpentersville Chief of Police Todd Shaver announce that **Alan U. Medina** and **Jimmy Medina** both are charged with the offenses of:

- First-degree murder (2 counts)
- Attempt first-degree murder, Class X felony (2 counts)
- Aggravated battery with a firearm, Class X felony (2 counts)
- Aggravated discharge of a firearm, Class 1 felony (2 counts)
- Possession of a firearm – ineligible for a FOID, Class 3 felony

State's Attorney Mosser alleges that during the evening of October 25, 2023, Alan Medina was driving his vehicle. His cousin, Jimmy Medina, was riding in the front passenger seat. While they were in the vicinity of the 1-99 block of Robin Road, Carpentersville, one or both fired multiple shots from a handgun in the direction of a vehicle containing multiple individuals.

A 17-year-old male from Carpentersville was struck in the head by a bullet and died that night. His name is being withheld at this time because of his age. A second victim was struck by a bullet and continues to recover. A third victim was grazed by a bullet, treated for the wound at a local hospital and released. Two others in the vehicle were uninjured.

Alan Medina was detained and will remain in custody until further order of the court. His next court appearance is scheduled for November 15, 2023, at 9 a.m. in Courtroom 313 at the Kane County Judicial Center.

Jimmy Medina is in custody at the Kane County Juvenile Justice Center awaiting a first appearance hearing, which is scheduled for November 3, 2023, at 9 a.m. in Courtroom 313 at the Kane County Judicial Center.

The case remains under investigation. Anyone with information should call the Carpentersville Police Department at (847) 551-3481, or (847) 428-8784 after hours.

The charges against Alan Medina and Jimmy Medina are not proof of guilt. Alan Medina and Jimmy Medina are presumed innocent and are entitled to a fair trial in which it is the state's burden to prove their guilt beyond a reasonable doubt.
