Batavia Man Sentenced to 25 Years for Aggravated Criminal Sexual Assault at Marklund Home in Geneva

RE: Isaiah Fields: Age 24 (d.o.b. 07-06-2001), of the 1800 block of Wagner Rd., Batavia, Illinois. Case No. 2024CF974

St. Charles, Ill. - Kane County State's Attorney Jamie L. Mosser announces that Judge John Barsanti has sentenced **Isaiah Fields** to 25 years of imprisonment in the Illinois Department of Corrections.

On January 14, 2025, Fields pled guilty the offense of aggravated criminal sexual assault, Class X felony. Assistant State's Attorney Matthew Rodgers stated the following facts in court. On or about August 1, 2023 through September 5, 2023, Isaiah Fields sexually assaulted the victim, who he knew had a severe or profound intellectual disability and was unable to give consent. The victim was a resident of Marklund Home in Geneva. It was discovered in April of 2024 that the victim was nearly fully pregnant, and the victim later gave birth. The Kane County Sheriff's Office conducted an investigation that involved securing multiple buccal swab DNA tests from current and previous male employees. After Fields' DNA test came back positive, the Sheriff secured a sealed order for his arrest.

In addition to the prison term, Fields must register for life as a sexual offender in accordance with the Illinois Sexual Offender Registration Act. In accordance with Illinois law, Fields must serve at least 85 percent of the sentence. Fields receives credit for 308 days served in the Kane County jail.

SA Mosser said: "Today's sentencing holds Isaiah Fields accountable for his heinous actions and the profound harm he caused to a vulnerable individual who was unable to protect themselves. The bravery of the victim's caregivers, the diligent work of law enforcement, and the efforts of my office ensured that justice was served. This sentence reflects the gravity of his crime, and we remain committed to safeguarding the most vulnerable members of our community from exploitation and harm."

ASA Rodgers said: "Isaiah Fields preyed on this vulnerable victim because of her physical and intellectual disability. While no sentence can undo the harm caused, today's outcome ensures that the defendant will be held accountable for his despicable act. It also represents justice for the victim, her family and the Marklund community. I'd like to thank the victim's family for their patience and support throughout the case. My additional thanks to Victim Advocate Linda Hagemann, Investigator Brooke Minuth of the Kane County Sheriff's Department, and Assistant State's Attorney Hillary Sadler for their tireless efforts in bringing this defendant to justice."
